

# The Amazing 1 Million Contest FAQ

## Eligibility

### **1. Do I qualify for The Amazing 1 Million Contest?**

The Contest is open to all CNI Enterprise (M) Sdn. Bhd. CBOs (CNI Business Owners) and Valued Customers except employees of CNI, their affiliates and/or their related companies.

### **2. How do I participate?**

To qualify for entries, CBOs must spend a nett minimum purchase of RM 50.00 (at Member Price) per invoice on any CNI's product in all categories within the Contest Period. Purchases can be made at CNI Distribution Channel or CNI's online mall at <https://cni.my/>.

### **3. Is there any limit in terms of age of participation?**

This contest is open only to CBOs or Valued Customers who are aged 18 and above.

### **4. Can I ask my family member or friend to participate in The Amazing 1 Million Contest on my behalf?**

The Amazing 1 Million Contest is open to all CNI Enterprise (M) Sdn. Bhd. CBOs (CNI Business Owners) and Valued Customers only. You may encourage your family member or friend to sign up as a CBO or Valued Customer.

## Qualifying Criterias

### **5. Is there any maximum limit for the invoice?**

No, any amount is allowed for each invoice. However, entries are only given based on the entry entitlement table which you find [here](#).

### **6. How do I submit my entry?**

You do not have to submit any physical entry. Entries will be generated automatically upon purchase and reflected in the current invoice.

### **7. Can I submit more than 1 entry?**

Entries are generated automatically with a maximum of 30 entries per invoice with a purchase of MP RM 400 and above.

### **8. Is there a limit to the total number of entries I can receive in a single invoice?**

Yes. The maximum number of entries that will be given is 30 entries with a purchase of MP RM 400 and above.

**9. Can I use a handwritten invoice given by an outlet?**

Entries are generated automatically in printed invoices when purchases are made at official CNI Distribution Channel or through CNI's online mall at <https://cni.my/>. Manual invoices are given only during system downtime. In that case, any entries earned from these purchases will be generated automatically once the purchase has been reflected into the system

Purchase of CNI products at other locations (apart from the above stated) will not be given any entries.

**Contest Draw Details**

**1. What is the Weekly Double Happiness Draw?**

The Weekly Double Happiness Draw is made up of two (2) parts.

Part one (1) is the Double Up Entries, where 50% of the weekly entries will be selected at random and these selected entries will automatically be doubled. The number of double up entries are based on the selected entries during each draw.

*Example 1: Sally has an invoice with a total of 3 entries. During the weekly draw, 2 out of her 3 entries were selected. The selected entries will automatically be doubled, making it a total of 5 entries (2 new entries + 3 current entries). All 5 entries will be added back to the draw pool for the subsequent Surprise and Grand Draw.*

Part two (2) is the Double Up Rewards where the 50% Double Up Entries (part one), 10 lucky winners will be selected at random to be rewarded with the same set of purchase made in the selected invoice.

*Example: John purchased 1 WaterLife Hot Spring unit & 3 boxes of Well3 L.E.A.F 20's in the selected invoice. John will get 1 New WaterLife Hot Spring unit & 3 more boxes of Well3 L.E.A.F 20's as reward.*

**2. Is the Weekly Draw based on purchases made in that particular week?**

Yes, it is. Example: Week 1 starts from 1 March 2020 (00:00 AM) until 7 March 2020 (11:59 PM). Winners for Week 1's draw will be selected from the purchase pool within this set date & time.

**3. Do I get the FOC/PWP products if my invoice that has FOC/ PWP products is selected for Double Rewards?**

No, only the main purchase will be Double Up. FOC & PWP items will be excluded.

**4. What happens to my entries that were not selected during the weekly draw?**

Entries that were not selected during the Weekly Draw will remain in the draw pool for the subsequent Surprise and Grand Draw.

**5. What happens to my Double Up Entries?**

The new entries awarded during the Weekly Double Up Entries will be added to the draw pool for the subsequent Surprise and Grand Draw.

**6. How many Weekly Double Happiness Draw winners will there be throughout the contest period?**

There are a total of 440 Double Up Reward winners throughout the contest period (10 winners made up of 2 from North region, 2 from Central region, 2 from East Coast region, 2 from South region and 2 from Borneo region).

As for the Double Up Entries, the number of winners will be 50% of the total entries for that particular week.

**7. How are the Weekly Double Happiness Draw winners selected?**

All contest entries are picked via a randomizer program to determine the winners. The Company's decision is final and no correspondence will be entertained.

**8. What are the weekly periods for this contest?**

Weekly submissions will start from every Sunday at 00:00 AM until the following Saturday at 23:59 PM. The weekly draw schedule can be found at the official contest website [here](#).

**9. If my entry has been picked during the Weekly Draw, does it still qualify for Surprise and Grand Draw?**

Yes, the entry would still qualify for Surprise and Grand Draw.

**10. Is it possible for the same CBO to win more than once during the Weekly Double Happiness Draw (Double Up Reward)?**

Yes, the same CBO can win more than once in the Double Up Reward of the Weekly Draw Double Happiness.

*Example: Sharon bought the following products on 2 separate days (within the same week).*

Invoice	Product	MP Price (RM)	No of entries
MEDTEMP19080553	WaterLife Hot Spring x 1 unit	RM 1,979.25	30 entries
MEDTEMP19080574	Well3 Lyophilized Royal Jelly 30's x 2 boxes	RM 93.50 x 2 = RM 187.00	4 entries

*Sharon is a lucky person and her entries from both invoices were randomly picked during Week 1 (Double Up Entries) and was awarded new entries that will be added to the draw pool for the subsequent Surprise and Grand Draws.*

*From the 50% selected Double Up Entries, her entries from both invoices were picked again for Week 1 (Double Up Reward). She will be rewarded with 1 unit of WaterLife Hot Spring and 2 boxes of Well3 Lyophilized Royal Jelly 30's.*

**11. How many Surprise Draw winners will there be in The Amazing 1 Million Contest?**

There are a total of 15 Surprise Draw Winners in The Amazing 1 Million Contest and there will be numerous surprise announcements throughout the contest period, thus there is no fixed date for the Surprise Draw. Any adjustments will be at the organiser's discretion.

**12. How are the Surprise Draw winners selected?**

The Surprise Draw winners will be selected in the same manner as Weekly Double Happiness Draw winners, via randomizer programme.

**13. What are the prizes for the Surprise Draw?**

As the Surprise Draw is a surprise, the prizes will not be pre-announced before the draw.

**14. When will the Grand Draw Prize Winner be announced?**

The Grand Draw will be held in January 2021 and an announcement on the date of the draw will be made by 1 December 2020. The Grand Draw prize winners will be announced at the live event.

## **15. How many Grand Draw prize winners will there be in The Amazing 1 Million Contest?**

There will be a total of 11 winners from the Grand Draw Category.

### **Winner Announcement**

#### **1. Where will the winners be announced?**

The winners will be announced on the CNI Business Centre App, The Amazing 1 Million Contest website (<https://cni.my/hero/>) and CNI Malaysia Official Facebook page.

The Weekly Draw (Double Up Reward) winners will be contacted via telephone by a representative of CNI. After which, the winners shall receive their reward redemption voucher within 7 working days via WhatsApp. The terms and conditions for the reward redemption voucher will be sent together with the voucher code and pin number via WhatsApp. The voucher codes are unique for each winner, following their CBO code.

As for the Weekly Draw (Double Up Entries) winners, a winner list will be made available on The Amazing 1 Million Contest website (<https://cni.my/hero/>).

#### **2. How will the Surprise Draw winners be informed on their winnings?**

The Surprise Draw shortlisted winners will be contacted via telephone by a representative of CNI. The Shortlisted winner's identity, identification number and member ID are required to be verified before being declared as the Winner.

The Organiser reserves the right to disqualify any shortlisted Winner if they do not fulfill the qualifying criteria and proceed to contact the next shortlisted Winner. The Organiser will inform the winners regarding the redemption process at the point of contact.

The Organiser reserves the right to forfeit the prize if the winner fails to respond to the Organiser's calls/ emails to the contact information available in CNI Business Centre Apps within seven (7) days from the notification of winning, inclusive of weekends and public holidays. Members are responsible to ensure their latest contact information has been updated via the CNI Business Centre App. Any decision to the Organiser to forfeit a prize or prizes shall be final and conclusive and shall be non-appealable.

#### **3. How will the Grand Draw winners be informed on their winnings?**

The Grand Draw winners will be selected through a physical draw at a live event in January 2021. The date of this live event will be announced by 1 December 2020 on the CNI Business Centre App, The Amazing 1 Million Contest website (<https://cni.my/hero/>) and CNI Malaysia Official Facebook page.

## Prizes

### 1. What are the prizes offered for this contest?

Summary of prizes as below:-

<b>Surprise Draw</b>	<b>15 lucky winners</b>	EXTRAORDINARY SURPRISES will be randomly announced throughout the contest period.
<b>Weekly Double Happiness Draw</b>	<b>Double Up Entries</b>	50% of the weekly entries will be selected at random and selected entries will automatically be doubled. The number of double up entries will be based on the selected entries during each draw.
	<b>Double Up Rewards</b>	From the 50% Double Up Entries, 10 lucky winners will be selected at random to be rewarded with the same set of purchase made in the selected invoice. Only the main purchase will be <i>Double Up</i> , FOC & PWP items will be excluded.

### 2. What are the criteria to get the RM 100,000 Cash Prize for the Super Grand Prize in the Grand Draw?

In order to qualify for the RM 100,000 Super Grand Prize (Cash Prize), the shortlisted winner must meet one of the following criteria:

- Must have a purchase of PSPV 200 or more every month throughout the Contest Period (1 March 2020 - 31 December 2020)
- Or accumulate equal or more than 3,000 PSPV throughout the Contest Period (starting from 1 March 2020 until cut-off date on 31 December 2020)
- For those who signed up as a Member anytime in 2020, regardless of the month, they will be eligible for the Super Grand Prize of RM 100,000 if they

fulfill the criteria of 200 PSPV per month, starting from the month they joined CNI.

If the shortlisted winner does not meet any of the three (3) criteria from page 6, he or she will be given the RM 10,000 Cash Prize instead.

**3. Can I decline to participate in the Weekly Double Happiness Draw and opt to keep my entries for the Surprise and Grand Draw?**

No, all entries are automatically entered into the 3 draws; Weekly Double Happiness Draw, Surprise Draw and Grand Draw.

**4. How can I claim my prize?**

The Winners will be contacted by CNI and informed about the redemption process at the point of contact.

**5. What do I need to present when I collect the prize?**

The Shortlisted winner's identity, identification number and member code are required to be verified before being declared as the Winner.

**6. How many prizes can participants win throughout the entire contest period?**

You can win multiple prizes via multiple entries throughout the contest period. However, the weekly entries will enter the Weekly Draw Double Happiness as per the Weekly Draw schedule. The Weekly Draw schedule can be obtained from the contest's official website (<https://cni.my/hero/>).

**Others**

**1. Where can CBOs check for their number of entries?**

CBOs can check their number of entries via CNI Business Centre, DC/ SC staff can assist to check CBOs' total entries to date at centres via CNIE POS system. It will also be reflected on the invoice after purchase.

**2. For entries given through WhatsApp Engagement Link, would they be entitled for the Weekly Double Happiness & Surprise Draw?**

Yes, entries given through WhatsApp Engagement Link will be entitled for the Weekly Double Happiness, Surprise and Grand Draw.

**3. I purchased some CNI products on 7 February 2020. Will I be entitled to entries for The Amazing 1 Million Contest?**

Following the announcement by CNI on 12 February 2020, CNI has prepared a special surprise for all CBOs whereby any purchases made from 1 February 2020 (00:00 AM) till 29 February 2020 (23:59 PM) will be entitled to entries for The Amazing 1 Million Contest, following the entry entitlement table. These

entries will be added to the first Weekly Draw of March on 10 March 2020 (Tuesday).

**4. Will the special February entries be entitled for the Surprise and Grand Draws?**

Yes, all entries awarded for February purchases will be entitled for the Surprise and Grand Draw.
