# **TERMS AND CONDITIONS**

**Event:** The Amazing 1 Million Contest (hereinafter referred to as the "Contest");

**Contest period:** 1 March 2020 – 31 December 2020 (both dates inclusive) unless notified otherwise (hereinafter referred to as the "Contest Period").

**Organiser:** CNI Enterprise (M) Sdn. Bhd. (hereinafter referred to as the "Organiser" or "CNI").

## **ELIGIBILITY**

 The Contest is open to all CNI Enterprise (M) Sdn. Bhd. CBOs (CNI Business Owners) and Valued Customers (hereinafter referred to as "Member") except all employees of CNI, their affiliates and/or their related companies.

#### **QUALIFYING CRITERIAS AND SUBMISSION OF ENTRIES**

- To qualify for entries, the Member must spend a nett minimum purchase of RM 50.00 (at Member Price ("MP")) and above per invoice on any CNI's product in all categories ("Product") within the Contest Period. Purchases must be made at CNI distribution centre (hereinafter referred to as "Centre") or CNI's online mall at <a href="https://cni.my/">https://cni.my/</a>.
- 2. Nett purchase shall mean the final amount stated in the invoice qualified for the Contest.
- 3. Qualification for entries is automated by our Point of Sale system based on invoice value.
- 4. The Contest entry entitlement is as follows.

- 6. Invoices can only be voided on the purchase date itself by Centre for combining Member's other invoices of the same date to enter the Contest. Any request after the purchase date will not be entertained.

#### **Contest Draw Details**

- 1. In this Contest, there will be three draw categories, Weekly Double Happiness Draw, Surprise Draw and Grand Draw.
- The Grand Draw will be held in January 2021 and an announcement on the date of the draw will be made by 1 December 2020. There will be a total of 11 winners from the Grand Draw Category.
